Dear Commissioner Howard:

I am writing on behalf of Hoboken University Medical Center (HUMC) to convey my strong support of their request for funding from the Health Care Stabilization Fund. As I know you are aware, the City of Hoboken acquired the hospital as recently as 2007 after considerable public debate and community support. We made this decision in recognition of its valuable contribution to the health and safety of our residents and their importance to our local economy.


HUMC is located in a geographically and culturally unique location which significantly shapes the role it plays in the delivery of healthcare to our community. HUMC is the third largest employer in our city and for more than 147 years this community not for profit and now public hospital has provided access to needed health care for residents of Hoboken, Union City, a significant portion of Jersey City, along with West New York and Weehawken. Roughly 60% of the primary service area population is Latino and next year's census figures will probably show an even greater proportion of minorities, chiefly from Spanish-speaking countries.

The Hospital is a safety net for women, children, the elderly and people living with HIV/AIDS. Their health status and ability to seek care is compromised by poverty, lack of insurance, low education levels, and significant cultural differences. Many of these and other uninsured and underinsured patients use clinic services at the Hospital-supported Center for Family Health as their entry to care. The majority of these patients are living below the Federal Poverty Income Guidelines. More than one third of the residents relying upon the Hospital have no insurance and another third have Medicaid coverage. The geographical outlines of the Hoboken UMC present a significant barrier to the ability of potential patients, particularly those with limited access to paid transportation, to seek care elsewhere.

OFFICE OF THE MAYOR

The recession and attending unemployment serve only to exacerbate the increasing lack of health coverage and access to needed medical care. These are difficult times for all of us but especially our vulnerable residents who rely on state and local government to provide a safety net for health and social services. The grant funds are necessary to preserve points of entry to access primary and related outpatient services. It is in that spirit that I simply urge and ask for your favorable consideration of the Hospital's application.

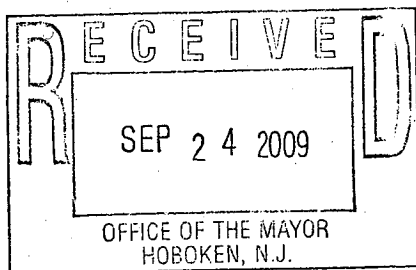
